Dear Senator Bennet,

We, the undersigned, write in strong support of the public lands and watershed protections included in the Gunnison Outdoor Resources Protection (GORP) Act. In the North Fork Valley, we know firsthand that protected public lands contribute to a healthy environment, our quality of life, and local economies on the Western Slope. Some of us have lived here for generations, others have joined our communities more recently, but we all agree that opportunities for outdoor recreation, wildlife conservation, and protections for clean water resources help support our way of life and directly contribute to the success of the many small farms, ranches, and other business throughout the area.

Specifically, we support in the GORP Act the inclusion of wilderness additions, special management areas, and mineral withdrawal areas in the North Fork watershed. These areas include the Clear Fork Special Management Area, Pilot Knob Special Management Area, Beckwiths Special Management Area, Horse Ranch Park Recreation Area, Munsey Creek Wildlife Conservation Area, Lamborn Wilderness Addition, and Erickson Springs Wilderness Addition. All of these areas are deserving of protection for their ability to improve water resources, wildlife habitat, and recreation opportunities to communities in the North Fork and Lower Gunnison watersheds. We also support the GORP Act provision to provide for continued public access to the Gunnison Forks (Pleasure Park) boat ramp.

Perhaps most important to those living in Delta County is inclusion of the North Fork Valley Watershed withdrawal in the GORP Act. As you know, this oil and gas withdrawal would apply to many of the Bureau of Land Management surface-managed areas in the County, while Currant Creek, Electric Mountain, and Elk Park Roadless Areas in the Grand, Mesa, Uncompangre and Gunnison National Forests would benefit from a No Surface Occupancy restriction. While this withdrawal will not fully protect the entire North Fork Valley watershed from future oil and gas development, it represents a significant step toward protecting critical areas like the Town of Paonia's source water area and Jumbo Mountain which had been previously open to oil and gas development.

The public lands and waterways of the North Fork Valley surround our communities and connect us. Protecting these connections and reducing carbon emission is especially critical for climate change adaptation and mitigation. Thank you for your work to support locally-driven conservation solutions on the Western Slope and elsewhere in Colorado. We encourage you to schedule a hearing and pass the GORP Act without delay and are looking forward to the day when these protections are permanently signed into law.
